Adult Education Program Policy and Requirements

The San Carlos Apache Tribe Adult Education Program Focuses to primarily fulfill education instructional and support services for tribal members of the San Carlos Apache Tribe toward earning a GED Certificate from the Blylas and San Carlos communities.

Data Requirements: (Failure to provide the following will result in non-enrollment from an incomplete file)

1. Must be 18 years of age or older
2. Must provide written proof of age: **Birth Certificate**
3. Must provide assigned ID number: **Social Security Card**
4. Must provide valid photo ID card: **Tribally or State-Issued**
5. Must provide proof of tribal enrollment of the San Carlos Apache Tribe (CIB); Non-members must be of Native American descent and provide proof of enrollment to other nationally recognized tribes.

Program enrollment requirements: (Failure to comply with the following will result in non-enrollment or a suspension in enrollment)

1. Must complete the GED/TABE pre-test
2. Must re-take the GED/TABE pre-test for non-attendance of 1 month or more
3. Failed status applicants must complete additional studying and review in a site-specific classroom setting prior to any consideration for GED Testing.
4. Must re-take the GED/TABE pre-test upon completion of review in subject areas failed to determine eligibility for GED Testing.

Services:

1. Online format through Aztec Software
2. Testing arrangements shall be scheduled for students who successfully pass the GED/TABE pre-test
3. GED testing shall be completed primarily at an official Testing Site.
4. Transportation services to the testing center may be available, schedule permitting, upon request.

Testing Fees/Awards (Note: Testing fees and awards are subject to budget availability for any period of a fiscal year. Should funding be unavailable, alternate arrangements will have to be made.):

1. First-time GED testing fees shall be paid on a one-time basis by the Adult Education Program for **students of Native American¹ descent who are enrolled for the current active fiscal year**. Each qualified student will be allowed a testing-fee waiver for a maximum of one full battery of the 2021 GED test to complete. **Any re-testing for failed portions of the GED exam will be the full financial responsibility of each student.**
2. Incoming GED enrollment or testing-fee requests to enroll or complete testing at other Adult Education programs/services located outside the San Carlos Apache Tribe Reservation **shall not be paid** as it will be at the requestor's expense to pay for such services since the San Carlos Adult Education Program funded services is only to fund services provided within the boundaries of the San Carlos Apache Tribe for its tribal constituents.
3. Incentives will **only** be awarded to **enrolled tribal members of the San Carlos Apache Tribe** who are **active fiscal year participants** under the Adult Education Program and shall consist of :
 - **Successfully passed students:** \$100 incentive plus *1 semester tuition and book expenses will be given as a scholarship for successfully passing the State GED Test
 - a. *Student must apply for FAFSA as award will be based upon need*

¹ Enrollment assumes a complete student file with the above "Date Requirements" and a completed GED/TABE pre-test on record.

- **Successfully passed students who average 175+:** \$100 incentive plus *2 semesters tuition and book expenses will be given as a scholarship for successfully passing the state GED Test upon meeting the following criteria:
 - a. Must show “Satisfactory Completed” classes upon conclusion of the semester
 - b. Must maintain a 2.50 GPA for continued incentive to be awarded
 - c. *Student must apply for FAFSA as award will be based upon need*
